- A new principal was announced this week for the upcoming year.

Mission moment:

- Theology curriculum review. Megan Spillers is complete with her review. She is unable to be here due to family leave. From the review by Lea, it seems to be one of the most thorough reviews Lea has ever seen.
- Brian shared highlights of the report. Not changing anything at LCHS after the reports of the review. Solid curriculum program after full review of the text books and teachings.

Principal's report:

- Current enrollment 92, registration for next year is 85.
- Basketball girls' and boys' teams are going to regional tournament this weekend, with both teams seated in first place.

- Kara, Nikelle & Shane: Kara asked some questions regarding current registered students and what the numbers are for students staying at school. Only six current families that have not responded to registration request Brian sent out. Brian is going to nudge the families to register or register the waitlist. 85 students registered for next year.
- Kara emphasized the need to monitor the students that are not returning on the reasons why.
- Kara also asked on the progress of targeting social media for marketing during the lottery season for public schools. Brian responded that the school is plugging away on social media this week because lottery applications are due March 19 for public schools.

• Finance & Development: Bill reported that the budget is in the works. 3% increase in tuition, base level wages increase, budget will be based on 85 students. From now until next Tuesday Brian, Dana and Bill working together to get that budget together to present to finance committee.

Finance report and accounting update -Bill & Danna:

Danna provided the Statement of Activities to board as pre-meeting reading materials.
 Nothing unexpected. A couple of maintenance items on there with the HVAC system and water fountains. Gala did extremely well. The Lumenary drive met their goal upward of \$66k. Also received money from the state. Looking positive going into the budgeting cycle.
